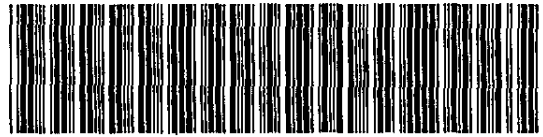

2. The foregoing amendment was adopted by the sole director of the corporation without shareholder action and shareholder action was not required as no stock has yet been issued.


