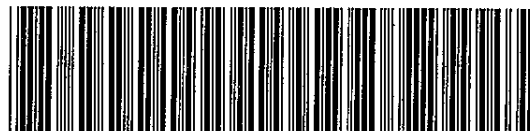

ARTICLE 1. NAME

The name of the corporation is the Family Education Foundation, Inc.

ARTICLE ADDRESS OF CORPORATION

The address of the corporation is 6810 Spencer Circle, Tampa, Florida.

ARTICLE DURATION

This corporation shall exist perpetually.

ARTICLE PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

The Foundation will create and provide educational materials to families to help them lead more productive lives.

ARTICLE CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1,000 shares of common stock of one class only, having no par value.

ARTICLE PREEMPTIVE RIGHTS

Every shareholder, upon the issuance of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his prorata share thereof at the price at which it is offered to others.

ARTICLE INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The street address of the initial registered office of this corporation is 6810 Spencer

Circle, Tampa, Florida, ³³⁶¹⁰ and the name of the initial registered agent of this corporation at that address is F. David Wolf.

ARTICLE DIRECTORS

The corporation shall have one directors initially. The number of directors may be increased or decreased from time to time, in accordance with bylaws adopted by the shareholders, provided, that the corporation shall always have the minimum number of directors required by law.

ARTICLE BY-LAWS

The power to adopt, alter, amend or repeal by-laws shall be by majority vote of the Board of Directors or by majority vote of the shareholders provided, however, that the Board of Directors shall not have the power to adopt, alter, amend or repeal by-laws if such action would be inconsistent with any by-laws adopted by the shareholders.

ARTICLE AMENDMENT

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be by the Board of Directors, proposed by them to the shareholders, and approved at a shareholders' meeting by a majority of the shares entitled to vote thereon.

ACCEPTANCE OF DESIGNATION

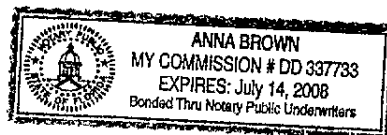
