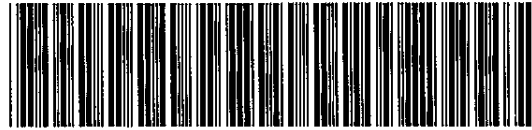

CORPORATE NAME**

The name of the corporation shall be:

**ARTICLE TWO
DURATION**

The term of existence of the corporation is perpetual.


