**ARTICLES OF INCORPORATION
OF

The Undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the Corporation is: **Cummings Construction Group, Inc.**

ARTICLE II - ADDRESS OF THE PRINCIPAL OFFICE

Located in Lee County, the principal place of business and street address of this corporation shall be: **1308 Bradford Road - Ft. Myers, Florida 33901**

ARTICLE III - PURPOSE
