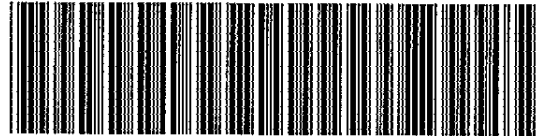

ARTICLE I

Name and Duration

The name of the SKS USA, Inc. The duration of the Corporation is perpetual. The effective date upon which this Corporation shall come into existence shall be the date these Articles are filed by the Secretary of State.

ARTICLE II

Principal Office

The address of the principal office of the Corporation is 8590 NW 72 Street, Miami, FL 33166

ARTICLE III

Registered Office and Agent

Corporate Purposes, Powers and Rights
