

ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

- Article 1. Name. The name of the Corporation is: DR. BORGES MEDICINE & MORE, INC. The principal office and the mailing address of the Corporation are 1830 Darlin Circle, Orlando, Florida 32820.
 - Article 2. Duration. The duration of the Corporation is perpetual.


