ARTICLES OF INCORPORATION OF ACQUALINA 601, INC.

The undersigned subscriber to these Articles Incorporation, a natural person competent to contract, he forms a corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of the corporation is ACQUALINA 601, INC.

ARTICLE II

DURATION AND BEGINNING OF CORPORATE EXISTENCE
