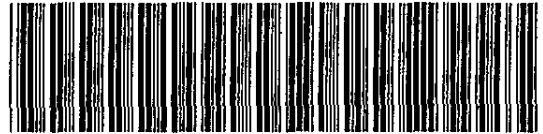



OF





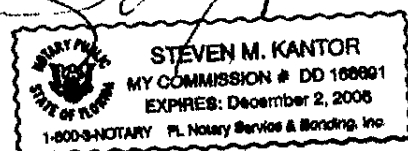
