The undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

**ARTICLE I – NAME**

The name of the corporation ("Corporation") is PATKO CO.

**ARTICLE II – CORPORATE DURATION**

This corporation shall have perpetual existence and shall commence upon the filing of these Articles of Incorporation.

**ARTICLE III – CAPITAL STOCK**


#### ARTICLE VII – INDEMNIFICATION
