SILVER SPRING GP, INC.**AMENDMENT TO ARTICLES OF INCORPORATION
(Changing Name to RRG Pennsylvania GP, Inc.)**

This corporation was incorporated on March 23, 2006 under the name Silver Spring GP, Inc. Pursuant to Sections 607.1001, 607.1003, 607.1004 and 607.1006, Florida Business Corporation Act, an amendment to Section 1.1 of the Articles of Incorporation was approved by joint unanimous written consent of the Board of Directors and sole shareholder of the corporation effective January 17, 2007. The only voting group entitled to vote on the adoption of the amendment consists of the holder of the corporation's common stock. The number of votes cast by such voting group was sufficient for approval by that voting group. Section 1.1 of the Articles of Incorporation of the Company is hereby amended in its entirety to read as follows:

"Section 1.1 Name. The name of the corporation is RRG Pennsylvania GP, Inc. (the "Corporation")."

This amendment shall be effective upon filing with the Florida Secretary of State.
