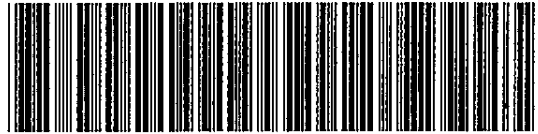

ARTICLE I

**NAME**

The name of the corporation is Pera Tile Installation, Inc..

**DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the department of state.
