ARTICLES OF INCORPORATION

THATCHER SECURITY, INC.

THE UNDERSIGNED subscriber to these Articles of Incorporation, a natural person, competent to contract, hereby forms a Corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is THATCHER SECURITY, INC.

ARTICLE II - NATURE OF BUSINESS

To the same extent as natural persons might or could do, the Corporation shall have the power:

- To carry on any lawful business whatsoever which the Corporation may deem proper A. or convenient, or which may be intended directly or indirectly to promote the interests of the Corporation or to enhance the value of its property.
- To do all things contemplated by, and to have all powers set forth in, Chapter В. 607.011, Florida Statutes, 1983, and as amended thereafter.

ARTICLE III - CAPITAL STOCK
