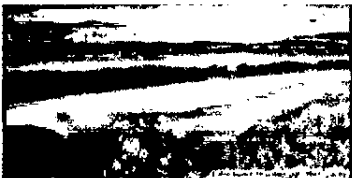

The undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I:** The name of the corporation is **LL Protection Advisors, Inc.**

**ARTICLE II:** The corporation shall exist for perpetuity commencing on the date of filing of these Articles.

**ARTICLE III:** This corporation is organized for the purpose of providing insurance services and any and all lawful business allowed under the laws of the State of Florida and/or the United States of America.

**ARTICLE IV:** The corporation is authorized to issue 1,000 shares of common stock, with no par value.


