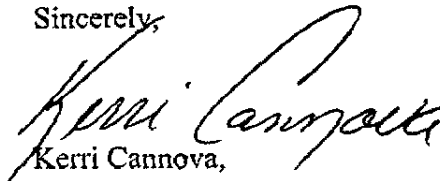

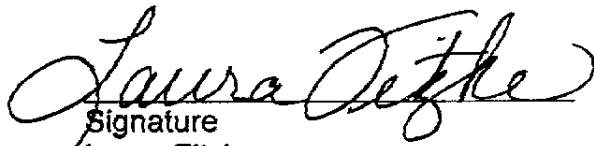
#### ARTICLE VIII. AMENDMENTS

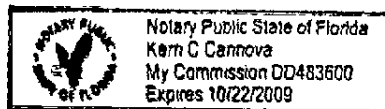

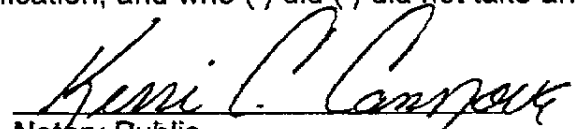
