In compliance with the requirements of F.S. Chapter 607, and FS Chapter 621, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of this corporation is: **EARTH VETS, P.A.**

ARTICLE II

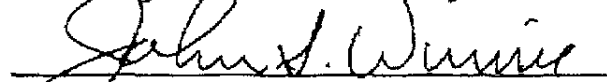

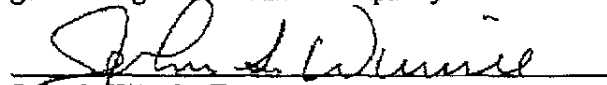
