INDEMNIFICATION

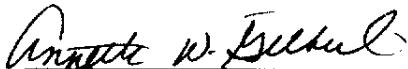

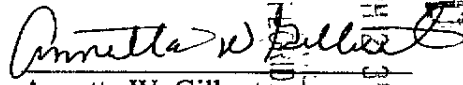

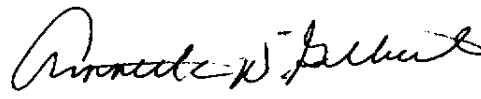
