The undersigned, acting as the incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is RAMSTAR CORPORATION.

ARTICLE II Commencement And Duration of Corporate Existence
