ARTICLE I -- NAME

The name of this corporation, formed under the provisions of Section 621, Florida Statutes, is MARCOS EGIPCIACO, P.A.

ARTICLE II -- PRINCIPAL OFFICE

ARTICLE III -- PURPOSE

The power to alter, amend or repeal the By-laws of this corporation shall be vested in each of the Board of Directors and the shareholders of this corporation.


ARTICLE IX - INDEMNIFICATION
