I, THE UNDERSIGNED, FOR THE PIRPOSE OF BECOMING A CORPORATION UNDER THE LAWS OF FLORIDA, BY AND UNDER THE PROVISION OF THE STATUTES OF THE STATE OF FLORIDA, PROVIDING FOR THE FORMATION, LIABILITIES, RIGHTS, PRIVILEGES, AND IMMUNITIES OF THE CORORATIONS FOR PROFIT, FILE THERE ARTICLES OF INCORPORATION.

ARTICLE I


THE NAME OF THE CORPORATION IS NUM AGE SPORTS & ENTERTAINMENT, INC.

ARTICLE II

THE GENERAL NATURE OF THE BUSINESS TO BE TRANSACTED IS AS FOLLOWS:

SECTION 1 A. SECTION 1 B. TO ENGAGE IN THE BUSINESS TO PROMOTE AND ORGANIZE SPORTING EVENTS, CONSERTS, AND MARKETING, PRODUCING ENTERAINERS ENT, WITH AN INPUT ON EVENT PLANING: TO OBTAIN BUSINESS CARDS, FLYERS, POSTERS, WEB DESIGNS, SEARCH ENGINE MARKETING, PROMOTIONAL PRODUCTS, AND MEDIA ADVERTISEMENT AND MARKETING CONSULTING.



SECTION 3: TO GENERALLY ENGAGE IN, DO AND PERFORM ANY ENTERPRISE ACT OR VACATION THAT A NATURE PERSON MIGHT DO OR PERFORM.

SECTION 4: TO ENGAGE IN AND CARRY ON ANY BUSINESS OR BUSINESSES AND ACT OR DEED PERTAINING THERETO, EITHER DIRECTLY OR INDIRECTLY, WHICH IS NOT PROHIBITED BY LAWS OF THE STATE OF FLORIDA, AND SO ENGAGE IN AND CARRY ON SAID BUSINESS OR BUSINESSES IN FLORIDA, OR OTHER STATES IN THE UNITED STATES OR IN ANY FOREION COUNTRY. TO DO ANY AND ALL THINGS NESSARY, SUITABLE, USEFUL PROPER OR ADMISSIBLE FOR THE ACCOMPLISHMENT OF ANY ONE OF PURPOSES OR ADMISSIBLE FOR THE ACCOPLISHMENT OF ANY ONE OF THE PURPOSES OR FOR THE ATTAINMENT OF ANY OF THE OBJECTS OR FURTHER EXERCISE OF THE POWERS HEREIN SET FORTH, WHETHER HEREIN SPECIFIED OR NOT, EATHER ALONE OR IN CONNECTION WITH OTHER FIRMS, INDIVIDUALS, OR CORPORATIONS, EATHER IN THIS STATE OR THROUGHOUT THE UNITED STATES AND ELSEWHERE.

ARTICLE III

THE FOREGOING CLAUSES SHALL BE CONSTRUED BOTH AS OBJECTS AND POWERS, BUT NO RECITATION, EXPRESSION OR DECLARATION OF SPECIFIC OR SPECIAL POWERS OR PURPOSES HEREIN ENUMERATED SHALL BE EXCLUSIVE, BUT IT IS HEREBY EXPRESSLY DECLARED THAT ALL OTHER LAWFUL POWERS NOT INCONSISTENT HEREWITH ARE HEREBY INCLUDED.

ARTICLE IV
