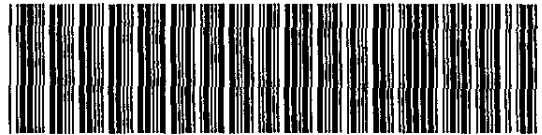

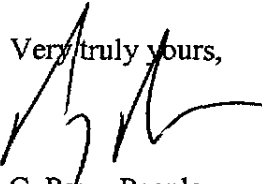

The undersigned, for the purposes of forming a corporation under Section 607.0202 of the Florida Business Corporation Act, does hereby certify as follows:

ARTICLE I

Corporate Name and Address

The name of the Corporation is D.M. MILLER AND ASSOCIATES, INC., and the street address of the Corporation is 950 7<sup>th</sup> Avenue South, Unit 25, Naples, Florida 34102.

ARTICLE II

Corporate Purposes

The Corporation is organized to transact any and all lawful business authorized by the Florida Business Corporation Act.

ARTICLE III

Authorized Stock

The aggregate number of shares of the Corporation shall be ten thousand (10,000), all of which are to be voting common stock having a par value of No Dollars and Fifty Cents (\$0.50) per share.

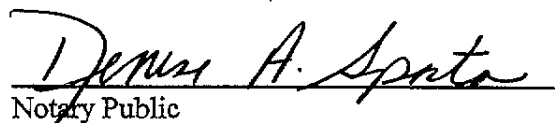
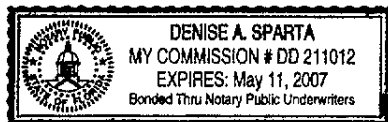
