ARTICLE 2 - NATURE OF BUSINESS


The Corporation shall engage in any activity or business permitted under the laws of the United States and the State of Florida.

5.1 The maximum numbers of shares that this Corporation is authorized to have outstanding At any time are ONE THOUSANDS (1000) stocks, each share having the par value of ONE DOLLARS (\$1.00) each.




