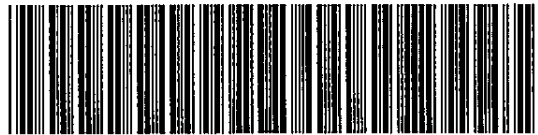

**ARTICLES OF INCORPORATION  
OF  
MOTHER NECESSITY, INC.**

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida under the corporation name of **MOTHER NECESSITY, INC.**, a Florida corporation, does hereby set forth and declare:

**ARTICLE I**

The name of the corporation shall be **MOTHER NECESSITY, INC.**

**ARTICLE II**

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

**ARTICLE III**

The authorized capital stock which the corporation may issued shall be **TEN THOUSAND (10,000)** shares of \$1.00 per value common stock, which shall be nonassessable and held, sold, and paid for at such time and in such manner as the Board of Directors may from to time determine.

**ARTICLE IV**

The corporation shall commence business on filing with the Secretary of State.

**ARTICLE V**

The corporation shall have perpetual existence, except that the same may be dissolved, as provided by law.

**ARTICLE VI**

The principal place for the transaction of its business shall be at 28971 Kiranicola Court, Bonita Springs, County of Lee, State of Florida 34135 and its mailing address shall be Post Office Box 2135, Bonita Springs, Florida 34133. That said corporation shall have the right and authority to do business at such other place or places within or without the State of Florida as the corporation may, by resolution, designate.

## ARTICLE VII

The Corporation shall have a Board of Directors of not less than one (1) director, which number may be increased or decreased from time to time. The number of directors each year shall be determined by the Shareholders at their annual meeting, unless the number is fixed by the By-Laws. 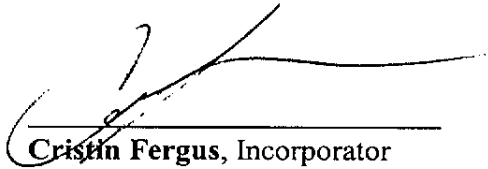

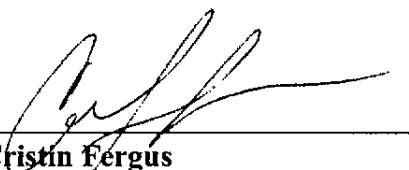
