**ARTICLE I
Name**

The name of this corporation shall be: **SKY CONSULTING, INC.**

**ARTICLE II
Principal Office and Mailing Address**

The address of the principal office and the mailing address of this corporation shall be 2632 South Dundee Street, Tampa, Florida 33629.

**ARTICLE III
Purposes and Duration**

The general purpose for which this corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Business Corporation Act of the State of Florida, and any amendments thereto, and in connection therewith, this corporation shall have and may exercise any and all powers conferred from time to time by law upon corporations formed under such Act.

**ARTICLE IV
Capital Stock**

This corporation is authorized to issue 1,000,000 shares of common stock, having a par value of \$0.01, which shall be designated as Common Stock.

**ARTICLE V
Registered Office and Registered Agent**

**ARTICLE VII
Directors and Officers**

This corporation shall initially have one (1) director. The number of directors may be increased or decreased from time to time by the shareholders, provided that this corporation shall always have at least one director. The shareholders of this corporation may remove any director from office at any time with or without

cause. Amir Glogau shall be the sole initial director of this corporation, who shall serve until the earlier of his death, incapacity, or the due election and qualification of his successor, and his address is 2632 South Dundee Street, Tampa, Florida 33629. Amir Glogau shall also be the initial President, Secretary, and Treasurer of this corporation and shall serve until the earlier of his death, incapacity or the due election and qualification of his successor

ARTICLE VIII
By-Laws

The power to adopt the by-laws of this corporation, to alter, amend or repeal the by-laws, or to adopt new by-laws, shall be vested in the Board of Directors of this corporation.

ARTICLE IX
Amendment of Articles of Incorporation
