ARTICLES OF INCORPORATION

OF

Pursuant to the provisions of Chapter 607, Florida Statutes, the undersigned Florida Corporation adopts the following Amended and Restated Articles of Incorporation. Corporation's Articles of Incorporation were filed on March 28, 2006; Document Number P06000045117.

ARTICLE I - NAME

These Amended and Restated Articles of Incorporation may be amended without a meeting as provided for in the Bylaws.

ARTICLE XI - ADOPTION

These Amended and Restated Articles of Incorporation were adopted and approved by a unanimous vote of the Directors of the Corporation and a unanimous vote of the Shareholders of the Corporation, which was a sufficient number to approve these

Amended and Restated Articles of Incorporation, on August 3, 2009.
