


To whom it may concern at the Divisions of Corporations,

My name is Raymond Mathews and I am the owner and sole employee of two very small corporations that I started last year ~~in order~~ to legitimize the money I make doing the two trades I do (playing and booking music gigs, and dog grooming) in which I have not had actual employment for two years. I thought that I could reap some of the benefits of corporation as well as the marketing angle of a corporate logo. Although business is increasing and has its good days the money brought in is hard earned and carefully spent. 2006 Fed. Tax Filing was negative and I also pulled from personal finances to establish both businesses. Also I have not accrued debt to cover my expenses, I earn the cash to I spend on supplies and tools, gas, etc. Corporation has been nothing but an expensive pain in the ass. November 2006 I receive two bills from the Company Corporation (these would be the people that did a lousy job helping me establish corporation for my two companies and cost \$400+ per corp.) for \$212. That of course is times two. When I called them for information I was told "this fee was to retain them as Registered Agent which is required by the state of Florida ." I still have yet figured out what that means. So I Spend the next two month busting my butt to come up with an extra \$400+ to pay this fee. I then receive from the state a lovely reminder card that I must file an annual report by May 1,2007 or I may be charged a late fee of \$400. Great, I pin this notice to my

Last Sunday April 29, 2007 I sit down at my computer and log on to sunbiz.org to file said report and find that not only am I supposed to pay \$150 to file (remember this is times two) which I don't have, but filing isn't much more than reconfirming the information I used when I opened business. Come Monday morning I have to figure out how to pull \$300 out of my yahoo before the close of business. By some grace of God I do it. I put the money in my bank account go home log on to sunbiz.org to once again try to file when your website kept telling me it could not access my information or I kept receiving a timed out error. My companies did not make enough money last year to hire a business manager, a lawyer, or an accountant, I had to take care of all these responsibilities myself. I work hard and am very talented at what I do, as well as I am honest with my taxes. I don't know how the state expects small business to survive in our constant up down economy, when they keep nickel-diming us over ridiculous fees. Inclosed is a check for the initial \$150, I tried to file on time and your system didn't allow me to, therefore I was stuck with the alternative of printing mailing (which I felt needed to include this letter) . I do not have the additional \$500 nor could I justify pulling from my personal finances.
