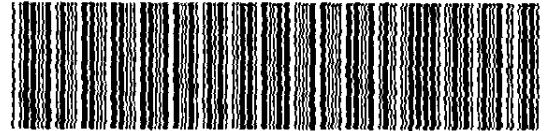

ARTICLE I, NAME

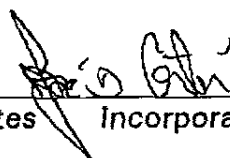
