ARTICLES OF INCORPORATION OF DAVID A, BEYER, P.A.

The undersigned, acting as sole incorporator, adopts these Articles of Incorporation and forms a professional service corporation (the "Corporation") under the Florida Professional Service Corporation Act (the "Act"), as follows:

Article I. Name

The name of the Corporation is David A. Beyer, P.A.

Article II. Term of Existence

The date when corporate existence will commence is March 24, 2006 in accordance with Section 607.0203(1) of the Act. The Corporation will have perpetual existence thereafter.

Article III. Principal Office

The principal office and mailing address of the Corporation is 101 East Kennedy Boulevard, Suite 2000, Tampa, Florida 33602.

Article IV. Nature of Business and Purposes

Article VII, Stockholders

The Corporation's Common Stock will be issued only to an individual who is duly licensed as an attorney under the laws of the State of Florida.
