

ARTICLES OF INCORPORATION OF

The undersigned subscriber(s) to these Articles of Incorporation, natural person(s) competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is: Florida Fence Products, Inc.

ARTICLE II. NATURE OF BUSINESS
