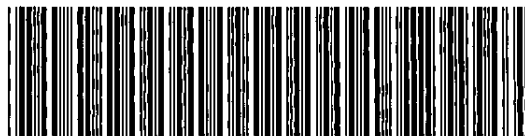

Pursuant to the provisions of Section 607.0704, 607.1001, 607.1003, 607.1004, 607.1005 of the
Florida Statutes, Pro Financial Holdings, Inc. adopts the following Article of Amendment to its
Articles of Incorporation:

Amendment adopted:

Article III, Section 1 of Pro Financial Holdings, Inc.'s Articles of Incorporation is hereby amended to read as follows:

ARTICLE III CAPITAL STOCK

Section 1 – Classes of Stock: The total number of shares of all classes of capital stock which the corporation shall have authority to issue is 51,000,000 consisting of:

- A. 1,000,000 shares of preferred stock; and
- B. 50,000,000 shares of common stock; par value one cent (\$0.01) per share.

The remainder of Article III remains unchanged by this amendment.

The foregoing Amendment was adopted by affirmative vote of a requisite number of the holders of the outstanding shares of common stock of Pro Financial Holdings, Inc., which was the only class of stock entitled to vote, through Written Consents to Action, which were obtained between March 29, 2012, and April 3, 2012.

IN WITNESS WHEREOF, the undersigned duly authorized officer of Pro Financial Holdings, Inc. executed this Article of Amendment as of this 3rd day of April, 2012.
