MANNER OF ELECTION OF DIRECTORS

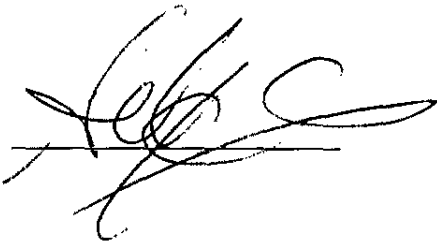
The number of directors may be altered from time to time by By-Laws adopted by the Shareholders. However, the Corporation shall have no less than one (1) Director at any time.

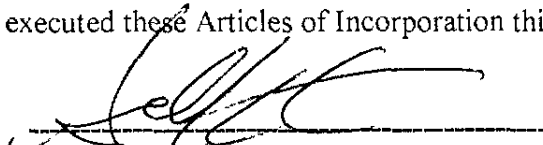
ARTICLE X

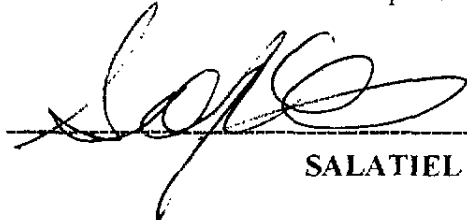
