

**ARTICLES OF INCORPORATION
OF
CONTRACTOR DRAFTING SERVICES, INC..**

In compliance with the requirements of F. S. Chapter 607, the undersigned being a natural person, hereby acts as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation shall be CONTRACTOR DRAFTING SERVICES, INC.

ARTICLE II

The existence of the Corporation shall begin on the date these Articles of Incorporation are filed.

ARTICLE III


