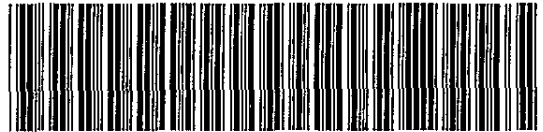

ARTICLE INAME


