

## ARTICLES OF INCORPORATION OF GORROW CONSTRUCTION, INC.



The undersigned subscribers to these Articles of Incorporation, natural persons in a competent to contract, hereby form a corporation for profit under the laws of the State of Florida.

#### ARTICLE I - NAME

The name of the corporation shall be GORROW CONSTRUCTION, INC.

#### **ARTICLE II - ADDRESS**
