ARTICLES OF INCORPORATION OF

Cool Air of Central Florida, Inc.

The Undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the Corporation is: **Cool Air of Central Florida, Inc.**

ARTICLE II - ADDRESS OF THE PRINCIPAL OFFICE

Located in Marion County, the principal place of business and street address of this corporation shall be: **1165 NW 105th Terrace - Ocala, Florida 34482**

ARTICLE III - PURPOSE
