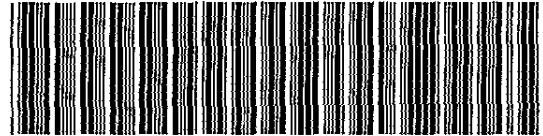

ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is Y & D Trucking, Inc. and its principal place of business shall be located at 7989 Oakstone Ct., Orlando, FL 32822.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transaction any or all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue one hundred (100) shares of common stock at One Dollar (\$1.00) par value, which shall be designated as "Common Shares".

ARTICLE V - PRE-EMPTIVE RIGHTS
