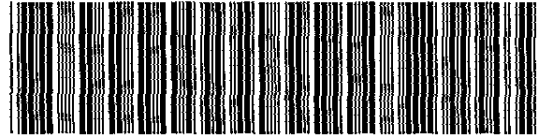

ARTICLES OF INCORPORATION FOR JUDY L. GRIFFIN, P.A.

I

The Name of the corporation shall be **JUDY L. GRIFFIN, P.A.**, whose principal office shall be located at 1511 Pinehurst Cove, Niceville, Florida 32578.

The duration of the corporation shall be perpetual.
