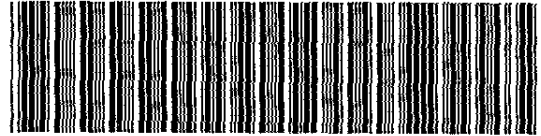

ARTICLES OF INCORPORATION

OF

JIM FRANCHER INCORPORATED

ARTICLE I - CORPORATE NAME

The name of this corporation is JIM FRANCHER INCORPORATED, whose initial principal office address is 124 Terry Street, Indian Harbour Beach, Florida 32937 and whose mailing address is 124 Terry Street, Indian Harbour Beach, Florida 32937.

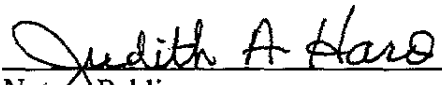

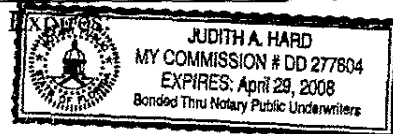
