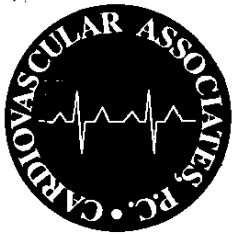

Why does your company want to penalize me ( James Sideris) twice for over the limit when I was unable to work to earn a living to pay the bills that become due.?

First: I was unable to work part-time for four (4) months due to my wife's open heart surgery at Providence Hospital, Mobile, Ala. by a great surgeon.

First: We were at Baptist Hospital, in Pensacola, fla. since Dec. 06 for pneumonia, which weakened Roula's heart also Diabetic. She had an angiogram done at Oschner's Clinic we stayed a week or more.

After leaving Baptist we went to Oschner's Clinic after being turned down for an open heart surgery.

Half-way between N.O. La. and Mobile, Ala. I had to call for an ambulance where she was taken to Providence hospital. Roula had her open heart surgery after all reports were in from Oschnes. I had to stay three weeks in the hospital with Roula to take care of her with the nurses around the clock.

After the operation and a Pacemaker inserted she had two operations. After recuperating somewhat Roula was sent to Re-hab at Mercy Medical at Daphne, ala. for two weeks.

Recovering partially we returned home where I am taking care of her. Any financial assistance you can give me will be a big help.

For instance lower payments and interest rates. Other companies have come to my aid under the circumstances to help until I return to part-time work. Other circumstances effected my and Roula's Social Security coverage on Medi-Care.
