

OF

SECRETARY OF STATE of Florida.

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the plant of Florida.

#### **ARTICLE I, NAME**

The name of the corporation shall be COX CONCRETE SERVICES, INC.

#### ARTICLE II, NATURE OF BUSINESS
