ARTICLE I - NAME

The name of this corporation is **AMERICA MOVING AMERICA, INC.**

ARTICLE II - DURATION

This corporation shall have a perpetual existence commencing on March 27, 2005.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of providing moving services intrastate and interstate and all-lawful business as allowed under the laws of Florida.
