**ARTICLES OF INCORPORATION
OF
A & A DISTRIBUTION AND SUPPLY COMPANY, INC.**

THE UNDERSIGNED, acting as sole incorporator of A & A DISTRIBUTION AND SUPPLY COMPANY, INC. (the "*Corporation*") under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I
NAME**

The name of the Corporation is "*A & A Distribution and Supply Company, Inc.*"

**ARTICLE II
SHARES**

The number of shares which the corporation shall have authority to issue is One Thousand (1,000), consisting of a single class of common stock, One Cent (\$0.01) par value per share. The Corporation shall not be authorized to issue a second class of stock.

**ARTICLE III
COMMENCEMENT OF CORPORATE EXISTENCE**

In accordance with Section 607.0203(1), Florida Statutes, the Corporation's corporate existence shall be deemed to have commenced at 12:01 a.m. on March 30, 2006, or, if later, such time and date as is five (5) business days prior to the date on which these Articles of Incorporation are filed by the Department of State.

**ARTICLE IV
PRINCIPAL OFFICE**
