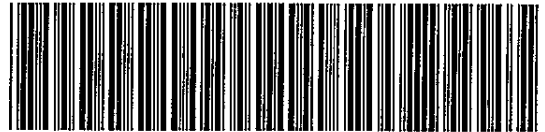

**ARTICLE I - NAME**

The name of the corporation shall be: FAUXTASTIC FINISHES BY S & S, INC.

**ARTICLE II - PRINCIPAL OFFICE**

The principal place of business is: 166 SW 84<sup>th</sup> Way

**ARTICLE III - DURATION**

This corporation shall have perpetual existence commencing on the date these Articles are filed with the Secretary of State.

**ARTICLE IV - PURPOSE**

The purpose for which the corporation is organized is to engage in any activity or business permitted under the laws of the United States and of this State, and to do everything necessary, proper, advisable or convenient for the accomplishment of said purposes, and to do all other things incidental to them or by other law, or by these Articles of Incorporation, and to carry out the said purposes in any state, territory, district, or possession of the United States, or any foreign country, to the extent that these purposes are not forbidden by the law of the state, territory, district or possession of the United States or by the foreign country.
