I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

**ARTICLE I - NAME**

The name of this corporation is Jsandi B-Ball Academy, Inc., and the initial address of this corporation shall be 5850 S. Pine Island Road, Davie, Florida, 33328.

**ARTICLE II - DURATION**

This corporation may engage in any and all lawful business under the provisions of Chapter 607, Florida Statutes, as it may be amended from time to time. The period of duration of this corporation shall be perpetual.

**ARTICLE III - PURPOSE**

The purpose of this corporation is to teach the sport of basketball, to hold team tournaments, and to create and run one or more basketball leagues but this corporation may engage in any lawful enterprise whenever or wherever located. The corporate existence shall commence upon the filing of these Articles of Incorporation.

**ARTICLE VI - INITIAL BOARD OF DIRECTORS**

This corporation shall have one director initially. The number of directors may be increased or decreased from time to time in such manner as may be prescribed by the bylaws, but shall never be less than one. The name and address of the initial director of this corporation is

The rights accruing to any person under the foregoing provisions shall not exclude any other right to which he may be lawfully entitled nor shall anything herein contained restrict the right of the corporation to indemnify or reimburse such person in any proper case though not specifically provided for herein.
