I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is Jsandi B-Ball Academy, Inc., and the initial address of this corporation shall be 5850 S. Pine Island Road, Davie, Florida, 33328.

ARTICLE II - DURATION

This corporation may engage in any and all lawful business under the provisions of Chapter 607, Florida Statues, as it may be amended from time to time. The period of duration of this corporation shall be perpetual.
