The Articles of Incorporation for the purpose of forming corporation under the Laws of the States
of Florida, Chapter 607 and subject to the following provisions:

ARTICLE ONE

The name of the Corporation shall be: K.C. Corporation of USA. INC.

ARTICLE TWO

This corporation shall have perpetual existence and may engage in any Activity or business permitted under the laws of the United States of Florida

The general nature of business to be transacted by this corporation shall Be:
