

AMENDMENT**



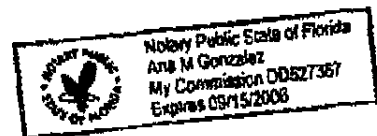
