

AMENDMENT**



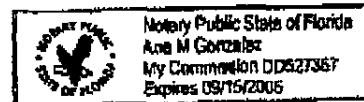
