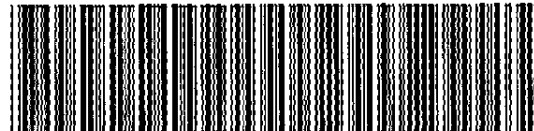

ARTICLE I - NAME

THE NAME OF THE CORPORATION SHALL BE A BUSY BUILDER INC.

ARTICLE II - PRINCIPAL OFFICE AND ADDRESS

THE INITIAL PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS OF THE CORPORATION IS MAILING ADDRESS, POST OFFICE BOX 937, HAVANA FLORIDA 32333 AND THE PHYSICAL ADDRESS IS 10 MASON COURT, HAVANA, FLORIDA 32333.

ARTICLE III - PURPOSE
