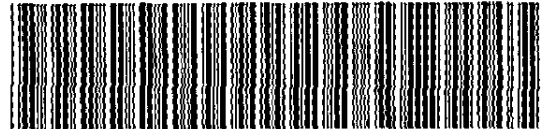



ARTICLE 1. - NAME

The name of the corporation is CRC WINDOWS/SHUTTERS, INC.

ARTICLE 2. - PRINCIPAL OFFICE

The principal office of the corporation shall initially be at 340 Island Circle, Sarasota, FL 34242.

The corporation may change its principal office from time to time as permitted by law.

ARTICLE 3. - MAILING ADDRESS

The initial mailing address of the corporation shall be 340 Island Circle, Sarasota, FL 34242. The corporation may change its mailing address from time to time as permitted by law.

ARTICLE 4. - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

This corporation reserves the right to amend or repeal any provisions contained in the Articles of


Incorporation, or any amendment to them, and any right conferred upon the shareholders is subject to this reservation.

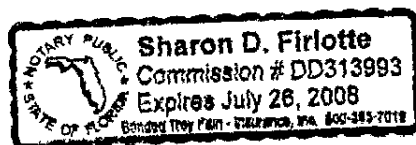
