The undersigned, for the purpose of forming a corporation under the Florida. General Corporation Act, does hereby adopt the following Articles of Incorporation:

#### ARTICLE I: NAME

The name of the Corporation is Samuel M. McMillian Jr. P.A. Principal place of business is 10090 Grove Lane, Cooper City, Florida 33328

#### ARTICLE II: DURATION

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual.
